Aldridge & Aldridge Accounting

Joe and Sandy Aldridge started their accounting business in the mid-1970s and operated it from their home for several years. Later they moved the business into the Ohio Valley Medical Center complex, where they rented space for 19 years. Aldridge & Aldridge Accounting occupied half of the building, and Dr. Michael Jones occupied the other half. Fourteen years ago they moved their business to the original Ogle's Market location on Main Street.

As their accounting business continued to grow, space continued to diminish in their Main Street location. So, in October 2013, Joe and Sandy purchased the Jones building at auction and began an extensive remodel in order to relocate their thriving business. The complex offers several advantages including being on one level, which makes it easier for clients to enter the building; allowing for more available parking for employees and customers; and more parking overall space. The new space provides individual office spaces for each employee, a consultation room where individuals can meet privately to discuss their financial matters, a large room for file storage, a nice break area, and a welcoming lobby space.

Aldridge & Aldridge Accounting employs a total of nine people year round, with two additional employees during tax season. We applaud the work of the Aldridge & Aldridge team in providing a much-needed service to many businesses and individuals in Hancock County and the surrounding area for over 41 years.
